

Dues deductions for academic year 2017-18

Dues for full-time members of Unit III are \$609.36 plus ½% of the annual contract salary for 2017-18.

Deductions for adjunct classroom and non-classroom faculty are the \$38.09 plus ½% of contract salary received, for earnings less than \$4,249 per semester. For earnings between \$4,250 and \$8,499 per semester, dues will be \$76.17 plus ½% of contract salary received. For earnings between \$8,500 and \$12,749 per semester, dues will be \$152.34 plus ½% of contract salary received. Earnings over \$12,750 will be \$199.59 plus ½% of contract salary received.

Those working under continuing and term appointments will have 19 deductions starting with the September 28, 2017 payday. Adjuncts will have four (4) deductions for both the fall and spring semesters.

Those having 19 deductions can find the amounts to be withheld by looking at the table in Column A at their 2017-18 step. Find your annual dues/agency fee in Column B and your biweekly deduction in Column C.
