

# Dues deductions for academic year 2018-19

Dues for full-time FA members of Unit III are \$609.36 plus ½% of the annual contract salary for 2018-19.

Deductions for adjunct classroom and non-classroom FA members are the \$38.08 plus ½% of contract salary received, for earnings less than \$4,249 per semester. For earnings between \$4,250 and \$8,499 per semester, dues will be \$76.17 plus ½% of contract salary received. For earnings between \$8,500 and \$12,749 per semester, dues will be \$152.34 plus ½% of contract salary received. Earnings over \$12,750 will be \$199.59 plus ½% of contract salary received.

Those working under continuing and term appointments will have 19 deductions starting with the September 27, 2018 payday. Adjuncts will have four (4) deductions for both the fall and spring semesters.

Those having 19 deductions can find the amounts to be withheld by looking at the table in Column A at their 2018-19 step. Find your annual dues in Column B and your biweekly deduction in Column C.
